As part of this project, iMPact trained staff with NIST SP 800-171 Cybersecurity guidelines and requirements and helped them to maximize current IT technology and staff capability. iMPact also worked with ACT to develop a cybersecurity plan. The company's client approved the plan and allowed the order pipeline to continue. As a result of this project, ACT also has documentation to prove they are following the guidelines and requirements for DFARS compliance.
